### Warranty:

No other warranties, expressed or implied, including warranties of merchantability and fitness for a particular purpose, shall apply to any products, goods, equipment, machine, spare part, replacement part, expendable or consumable part purchased by buyer from ITS-tec, except as expressly provided herein below:

- 1) Any complete new machine purchased by buyer from ITS-tec is warranted against defects in workmanship and material under normal use and service for a period of one (1) year after date of shipment to buyer.
- 2) Any new spare or replacement part (but not including any expendable or consumable part) is warranted against workmanship and material under normal use and service for a period of three (3) months after date of shipment to buyer.
- 3) No warranty whatsoever applies to any used machines, used spare parts, repaired spare parts and modifications on machine out of warranty. There could be a special agreement between ITS-tec and customer about the possibility of warranty, then and only then this point 3) is out of terms.
- 4) No warranty whatsoever applies to any expendable or consumable part whether sold separately or as a component of a complete machine.
- 5) ITS-tec shall have no responsibility whatsoever for damage or condition caused by ordinary wear and tear, accident, or by buyers fault or negligence, including but not limited to improper installation by or in behalf of buyer, or the use of any unsuitable part or attachment.
